## Terms and Conditions – Affiliate Program

---

1. Advertisers agree that no offensive or lewd signage will be permitted
2. Advertisers agree that no advertising that may be deemed to be in competition with Goosies will be permitted to be displayed
3. Advertisers/Sponsors agree that Goosies will not be responsible for providing signage including design and will be at the sole responsibility and expense of the Advertisers/Sponsors to supply correctly formatted signs

### **Digital Sign**

4. Monthly
  - a. If the monthly option is chosen, an agreement must be signed and payment made and cleared prior to any advertising being displayed
  - b. Once payment is cleared, advertising will commence on the 1<sup>st</sup> of the following calendar month and will cease on the last day of that month
  - c. An advertiser may continue to advertise by notifying Goosies of their intention and to ensure clause 6.a is adhered to
5. Annual
  - a. The annual option runs for a period of 12 months and is continuous with no breaks
  - b. If the annual option is chosen, an agreement must be signed and the first payment made and cleared prior to any advertising being displayed
  - c. Once payment is cleared, advertising will commence on the 1<sup>st</sup> of the following calendar month
  - d. A monthly invoice will be sent through at the beginning of every month for the following month
  - e. Payment terms are 7 days net at the start of the calendar month
  - f. The agreement will cease once the 12 months of continuous advertising is complete
  - g. In the event payment is not received according to these terms, advertising will cease until payment is made

### **Greens/Rink Advertising**

6. Rink sponsorship or advertising
  - a. Rink advertising is available for a period of 12 months
  - b. Advertisers/Sponsors are responsible for the supply of the signs to be installed
  - c. Once supplied, Goosies will organize installation at no expense to the Advertiser/Sponsor
  - d. Rink sign size will be 600mm wide x 360mm high

- e. Greens sign size will be 1800mm wide x 1100mm high
- f. The actual signage is at the cost of the advertiser
- g. Goosies can organize signage at a cost to the Advertiser/Sponsor
- h. Once payment is cleared and the sign has been delivered to Goosies, the sign will be installed by Goosies and remain in place for a period of 12 calendar months
- i. Placement of the advertising will be at the discretion of Goosies
